IMPORTANT INFORMATION FOR DOG OWNERS:

Any change in the particulars contained in this application, including change in address or ownership, sale or death of dog MUST be notified to Council in writing, (signed and dated).

Dogs three months and over must be registered at all times. Failure to register a dog may result in a penalty under the Dog Act. Dog registrations expire on 31st October each year.

Microchipping: All new dogs, i.e. pups and other dogs being registered for the first time, and dogs where ownership is changing, will need to be microchipped. All dangerous dogs have to be microchipped. All other dogs will have to be microchipped after 1 November 2015.

Dogs must wear a collar with the owner's name and address, and a current registration tag when in a public place.

Dogs are to be under the control of a competent person on a maximum 2 metre lead when out in public.

Dogs are to be exercised off a leash in designated areas only, with the person in control carrying a lead to ensure the dog can be restrained if required.

Please note that under the *Dog Act*, un-chipped dogs are not to be released from a pound until microchipped at the owner's expense.

Eligible pensioner means a recipient of the Age or Veteran Pension, as per the *Rates & Charges Act 1992*.
